February 27, 2023

The Board of Trustees of the Corsicana Independent School District met in a Board Meeting at 4:30 p.m. on Monday, February 27, 2023 at the Corsicana ISD Dr. Kent Rogers Administration Building, 2200 W. 4<sup>th</sup> Ave., Corsicana, Texas.
