



CISD BOARD REPORT

A Summary of the Board of Trustees Meeting

February 12, 2024

The Board of Trustees of the Corsicana Independent School District met in a Board Meeting at 5:00 p.m. on Monday, February 12 at the Corsicana ISD Dr. Kent Rogers Administration Building, 2200 W. 4th Ave., Corsicana, Texas. The meeting was called to order by Dr. Seth Brown, President of the Board of Trustees.

The meeting was called to order at 5:00 P.M.

Superintendent Report

Dr. Frost update the Board and the audience on district events taking place this week.

Superintendent Diane Frost announced that she will retire at the end of June 2024.

Closed Session

The first closed session began at 5:10 P.M.

The Board of Trustees reconvened into open session at 5:20 P.M.

Action as a Result of Closed Session

On a motion by Barbara Kelley and seconded by Leah Blackard, the Board of Trustees voted to hire Kandra Rogers at the new Assistant Principal at Collins Intermediate School. The motion passed unanimously.

On a motion by Barbara Kelley and seconded by Leah Blackard, the Board of Trustees voted to hire Terrance Lewis as the Associate Head Football Coach. The motion passed unanimously.

Food Service Department Update

Stephanie Howell updated the Board on income made and meals served by our food services department.

Resolution: Volunteer Chaplain

Dr. Frost explained that TEC Section 23.001 permits districts to employ or accept chaplains as volunteers. Senate Bill 763 required districts to vote as to whether to adopt a policy authorizing the district to employ or accept chaplains as volunteers. Corsicana ISD recommends retaining Local Policy GKG which allows chaplains to provide support, services and programs in accordance with the current policies. This item will be approved at the February 26, 2024 Board Meeting.

First Reading: TASB Update 122

Dr. Frost advised the Board that TASB policy update 122 is made up almost exclusively on legislation from the 88th Regular Legislative Session. Local policy changes impact Cybersecurity, Safety and Security, Accelerated Instruction, Class Rank, Attendance, medical Treatment for Students (opioid antagonists), and Crisis Intervention. Update 122 will be presented at the February 26, 2024 board meeting for approval.

Order of Trustee Election

On a motion by Jamie Roman and seconded by Barbara Kelley, the Board of Trustees voted to order the election for CISD Board of Trustees Place 3 and 4 to be held on May 4, 2024.

The motion passed unanimously.
