May 15, 2023

The Board of Trustees of the Corsicana Independent School District met in a Board Meeting at 4:30 p.m. on Monday, May 15, 2023 at the Corsicana ISD Dr. Kent Rogers Administration Building, 2200 W. 4th Ave., Corsicana, Texas. The meeting was called to order by Dr. Seth Brown, President of the Board of Trustees.

Mrs. Howell informed the Board of the trainings that the department participated in as well as areas of improvement goals she has in place for the 2023-2024 school year.

School Health Advisory Council (SHAC) Report

Shade Boulware gave the SHAC Report. Every 3 years, the CISD Wellness Plan is to be re-evaluated. This year the plan was re-evaluated and goals of wellness were discussed. Those goal areas included nutrition promotion, nutrition education, and physical activity.
