- Additional Teaching Units for 2014-2015 School Year
 The District is requesting the following additional teachers: 1-CHS

 CTE (Career Technology Education). On a motion by Ms. Blackard and seconded by Mr. Saberton, the Board voted to approve the four additional secondary teaching units for the 2014-2015 school year. The motions passed unanimously.
- Authority to Authorize a Commercial Contract-Improved Property Approve the Superintendent to execute a 'Commercial Contract-Improved Property' documents necessary for the sale of the property located in Block 318 of the City of Corsicana (the Administration Building, SF Austin Schoolhouse, and two warehouses) as well as such other steps as may be reasonable and necessary, including the execution of other standard documents (deeds, settlement statements and closing documents, etc.) to effectuate and close the transaction described in such Commercial Contract. On a motion by Rev. Monk and seconded by Mr. Saberton, the Board voted to authorize Superintendent, Dr. Diane Frost to execute the 'Commercial Contract-Improved Property' and to take such steps as may be reasonable and necessary.
