

CISD BOARD REPORT

A Summary of the Board Of Trustees Meeting

Nov. 5 & 12, 2012

Mrs. Laura Green and Mrs. Judy Paschal, GT teachers and 5th grade students presented a PowerPoint of an overnight trip to an "outdoor school" camp they are planning to attend.

Modifications to standardized mode of dress were presented for the Board to review. The Board voted and approved the modifications which include:

- 1. Hose/tights socks must be of a solid single, approved uniform color.
- 2. Socks must match each other and be any of the approved colors.
- 3. Socks may have logos.
- 4. Shoe laces may be worn as the manufacturer intended.
- 5. 'No show' socks of any color may be worn.
- 6. Belts may be any of the approved colors, or a combination of any approved colors.
- 7. Pullover sweatshirts with drawstring hoods are allowed. These must have the CISD logo or the logo of a school-sponsored team or organization.

Dr. Frost discussed the changes to policies in TASB Update 95. The changes were approved.

The Board voted to approve the purchase order to Presido/INX for computers for \$373,546.25. The computers are part of the Technology plan to integrate into CISD.

The Board voted to approve the class size waivers for Bowie and Carroll.

Mr. O'Neil, Principal of Corsicana High School presented a course change for Commercial Photography to a CTE class for the 2013-2014 school year.

Ms. Faulk, Director of Human Resources presented information on the revised list of certified appraisers for 2012-2013. She reported that all teachers and instructional aides are 'highly qualified.'

Dr. Frost reported that CISD received a letter from the Texas Education Agency designating Carroll Elementary and Sam Houston Elementary as PreK Centers of Excellence. Mrs. Darlene Jackson and Mrs. Darla Nolen were presented a banner for their campuses.

Ms. Sharon Barton gave an end of year report on READ 180 and System 44 programs.

Mr. Kevin Phillips, Principal of Navarro Elementary presented a power point on Navarro Elementary System of Learning.

The Board voted to approve the consent agenda which consisted of:
