- Approve purchase of Ford 350 Super Duty Truck for CISD Agriculture Department
 - Marti Shaner provided information on the purchase of a one ton, crew cab pickup for the CISD Agriculture Department. The purpose of the purchase is for the Ag Department to be able to transport its trailers and projects to various contests across the state. CISD sought proposals from three (3) local car dealers in Corsicana. The best proposal came from Brinson Ford in the amount of \$36,510.00. Ms. Shaner recommended the purchase from Brinson Ford. On a motion by Mr. Saberton and seconded by Mrs. Kelley, the Board voted to approve the purchase of a Ford 350 Super Duty truck for the Agriculture Department at CHS, from Brinson Ford. The motion passed unanimously.
- Approve purchase of CISD Police Department vehicles

 approve the purchase of three (3) fleet cars from CAP Fleet Upfitters for
 \$81,975.46 to complete the 2014-2015 vehicle cycle for the CISD Police
