

Family Engagement Policy

PART I. GENERAL EXPECTATIONS

Collins Intermediate agrees to implement the following statutory requirements:

1. Collins Intermediate will take the following actions to involve parents in the joint development of its school parental involvement plan under section 1118 of the ESSA:

lii. The school will convene the meeting at a time convenient for parents and will offer a flexible number of additional parental involvement meetings, such as in the morning or evening, so that as many parents as possible are able to attend. The school will invite all parents of children participating in Title I, Part A programs to this meeting, and will encourage them to attend by:

- *Invite parents to the Title I Part A meeting by sending invitations home in folders and posting on ClassDojo.
- *Collins Intermediate will offer meetings on different days at different times.

liii. Collins Intermediate will provide parents information in a timely manner about Title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children 's progress, and the proficiency levels students are expected to meet by:

- *Providing information on the State's expectations on our campus website and social media for parents.

5. Collins Intermediate will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible by:

- *Scheduling parent-teacher conferences on any given day during the teacher's conference period, before school, or after school.

- *We will also convene 504 meetings as often as needed to help the student.

- *Collins Intermediate has an open-door policy

6. Collins Intermediate will provide each parent an individual student report about the performance of his/her child on the State assessment in at least math, language arts and reading by:

- *Providing results to parents in Monday Folders.

- *NCLB Report Card and/or School Report Card will be provided to parents.

- *All testing; including common based assessments and benchmark test scores will be communicated to the parents.

7. Collins Intermediate will help parents of children served by the school, as appropriate, in understanding topics such as:

- *the state's academic content standards,

- *the state's student academic achievement standards,

- *the state and local academic assessments including alternate assessments

- *how to monitor their child's progress, and

- *how to work with educators

8. Collins Intermediate will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by:

- *PTO meetings

- *Meet the teacher night with curriculum training and resources provided to help our parents

- *Utilizing the CISD Wraparound Services

9. Collins Intermediate will , with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:

- *Utilizing CISD Wraparound Services
- *Collins Intermediate school programs and performances

10. Collins Intermediate will, to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities such as parent education meetings and campus academic performance meetings.

Collins Intermediate will take the following actions to ensure that information related to the school and parent-programs, meetings, and other activities is sent to parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable , in a language the parents can understand:
