Navarro Central Appraisal District

The Navarro Central Appraisal District Presented a plan to purchase, remodel and finance a property at at 4000 W. 2nd Ave.in Corsicana at the old Texas Youth Commission Education Building number 249. As a taxing entity, the CISD Board was asked to approve this activity.

On a motion by Seth Brown and seconded by Barbara Kelley the Board of Trustees voted to approve the acquisition and remodeling of a new facility at 4000 W. 2nd Ave, Corsicana – TYC Education Building #249 for the Navarro Central Appraisal District. The motion passed unanimously.
