August 5 & August 26, 2019

The Board of Trustees of the Corsicana Independent School District held a board workshop on Monday, August 5, 2019 and a regular board meeting on Monday, August 26, 2019. The meetings were called to order by Mrs. Leah Blackard, President of the Board of Trustees.

Guest Presentation

Prior to the board workshop on August 5, 2019, Dr. Kingman trained the Board of Trustees, Administrators, Principals, Assistant Principals and other present on how to "Stop the Bleed". The training showed attendees how to stop a person from bleeding from their core and extremities. The training also included proper ways to apply a tourniquet. Dr. Kingman also had 'Stop the Bleed' kits available for purchase.

Closed Session Action

As a result of closed session, Father Ed Monk moved to hire Mike Nielsen as Assistant Superintendent of Business Service. Dr. Kent Rogers seconded the motion. The motion passed unanimously.

M&O Tax Rate and Debt Service Tax Rate

On a motion by Dr. Kent Rogers and seconded by Barbara Kelley, the Board of Trustees voted to approve the 2019-2020 M&O tax rate of .97000 per \$100 valuation and a Debt Service (I&S) tax rate of 0.31310 per \$100 valuation for a combined tax rate of \$1.2831 per \$100 valuation. The motion passed unanimously.

Additional Bowie Staff

On a motion by Barbara Kelley and seconded by Father Ed Monk, the Board of Trustees voted to approve hiring additional staff at Bowie Elementary. The motion passed unanimously.

New Routers for District

On a motion by Dr. Kent Rogers and seconded by Father Ed Monk, the Board of Trustees voted to approve the purchase of new routers from TFE needed to replace the AT&T routers when the district changes internet service provider from AT&T to Cogent. The motion passed unanimously.
